Pursuant to Article 13, paragraph 2 of the Law on Higher Education and Scientific Activity (Narodne Novine, No. 119/22), Article 45 of the Statute of the University of Dubrovnik, Article 3, paragraph 2 and Article 15, paragraph 2 of the Law on the Student Council and Other Student Organisations (Narodne Novine, No. 71/07) and in accordance with Article 9 of the Statute of the Student Council of the University of Dubrovnik and Article 5 of the Rules on the Conduct of Elections for the Student Council of the University of Dubrovnik, I hereby issue:

DECISION
on amendments to the Decision on Calling Student Elections
for the Student Council of the University of Dubrovnik

1. In the Decision on Calling Student Elections for the Student Council of the University of Dubrovnik (No. 2417/25 of November 25th 2025; hereinafter referred to as: the Decision) point 2 amended and shall read as follows:

„2. The elections for student representatives of undergraduate and graduate study programmes to the Assembly of the Student Council of the University of Dubrovnik shall be held on Wednesday, February 18th 2026, from 8.00 am to 8.00 pm., and shall be conducted by direct voting using ballot papers.”

2. Point 3 of the Decision is amended and shall read as follows:

„3. In the elections referred to in the preceding point, a total of twenty (20) student representatives shall be elected, as follows:

- **two (2) representatives of undergraduate study programmes and one (1) representative of the graduate study programme of the Faculty of Maritime Studies, University of Dubrovnik;**
- **two (2) representatives of undergraduate study programmes and one (1) representative of graduate study programmes of the Faculty of Economics and Business, University of Dubrovnik;**
- **two (2) representatives of undergraduate study programmes and one (1) representative of the graduate study programme of the Faculty of Electrical Engineering and Applied Computing;**
- **two (2) representatives of undergraduate study programmes and one (1) representative of graduate study programmes of the Faculty of Media and Public Relations, University of Dubrovnik;**
- **two (2) representatives of undergraduate study programmes and one (1) representative of the graduate study programme of the Department of Applied Ecology, University of Dubrovnik;**
- **two (2) representatives of undergraduate study programmes and one (1) representative of the graduate study programme of the Department of Art and Restoration, University of Dubrovnik;**
- **two (2) representatives of the undergraduate study programme History of the Adriatic and the Mediterranean;**

and all students enrolled in these study programmes within the listed electoral units shall be entitled to participate in the elections for the aforementioned student representatives.”

3. Point 9 of the Decision is amended and shall read as follows:

„9. Candidates for student representatives of undergraduate and graduate study programmes to the Assembly of the Student Council of the University of Dubrovnik may submit their applications electronically, using the form available at www.unidu.hr or by completing the form available for

collection at the reception desks of University buildings. The completed candidacy form must be submitted to the following e-mail address: ured@unidu.hr or delivered in person to the Rectorate of the University of Dubrovnik, Branitelja Dubrovnika 41, 20 000 Dubrovnik no later than Friday, February 6th 2026, by 4.00 pm.

4. Confirmed student candidacies submitted on the basis of the Decision shall remain valid and the Election Committee is hereby instructed to adopt the updated electoral registers and candidate lists (as established by Decisions No. 43-2/26 and No. 43-3/26 of January 9th 2026) in accordance with this Decision and within the time limits prescribed by the Law on the Student Council and Other Student Organisations (Narodne Novine, No. 71/07) in both Croatian and English and to deliver them to the appointed polling committees.
5. Official notices regarding the student elections and the electoral actions carried out in this electoral procedure shall be published on the website of the University of Dubrovnik in both Croatian and English.
6. This Decision shall enter into force on the day of its adoption and shall be published on the website of the University of Dubrovnik.
